

**Hailey Fire Department**  
**PERMIT FEE SCHEDULE (Revised November 2011)**

**General Fire & Life Safety Plan Review Requirement:** (25% of Building Plan Review Fee)

All new building construction and remodel projects will be subject to a general fire safety and life safety site review. This site review will insure that adequate fire lanes, signage, hydrants, and other fire safety features are addressed in the planning stages. Building located within the designated Urban/Wildland interface areas, will be reviewed for special requirements pertaining to that hazard. This fee will also include the local plan review and installation permits necessary for the installation fire suppression system or fire alarm system that may be required for the building, when the plans for these systems are submitted concurrently with the initial building construction plans.

**Exemptions**

Single family and duplex dwellings are generally exempt from this inspection and fee if they:

- are less than 35 feet in height, or
- are not located within a designated Urban/Wildland Interface zone, or
- Have a total floor area less than 9,400 Square feet.

**Fire Protection System Installation Permits:**

Basic permit fees for a fire sprinkler and fire alarm systems are waived when complete plans for these systems are submitted to the city concurrently with the building construction plans. Fire suppression and/or alarm system plans submitted after the building permit application shall be assessed an additional fee equal to 25% of the Building Plan Review Fee. This fee is apportioned as follows:

- 3.5% Fire Alarm System Plan Review
- 3.5% Fire Alarm Installation & Inspection
- 8% Fire Sprinkler System Plan Review
- 10% Fire Sprinkler Installation and Inspection

Fire suppression and/or alarm system plans not associated with any building permit shall be subject to an hourly assessment for time spent reviewing and inspecting that system, or a fixed fee as established below.

**Installation/Construction Permits:**

Installation/Construction permits are issued for the installation of life safety systems within a building, and require additional technical inspections to insure that they have been professionally designed, installed and maintained according to approved plans.

## Operational Permits:

Operational permits are issued to businesses and persons who have operations that are regulated by the International Fire Code (IFC). These items may include the storage of a hazardous substance that exceeds the exempt amount as specified in this code. Specific Processes may also be regulated due to the specific hazard presented by these occupancies. All Operation Permits will have a specified expiration date.
