With current bonding estimates, it composes approximately 17%, Hennessey, line item 66, in spreadsheet, \$280,000 bonded for 150%. The \$280,000 is adequate to cover the connections to our system. The State of Idaho has suggested adopting these codes by January 2021, 2018 IBC codes as amended by the State of Idaho, more stringent, recommending IRC, ISPSC, in packet, organized code differently, which code was amended, retained build better code, exception of wood waste as there is no buyer for that wood right now. Fees are being adopted separately. Added language for 20 year storm.7:00:43 PM items removed are shown with stricken language, new language is underlined.

7:01:55 PM Thea has 2 questions, we just passed this resolution, how much better will be with the new resolution. And why take out the wood recycling? Is it never going to happen again? Why not leave it in? Bundy, issue with the wood, very little clean wood lumber now, mostly engineered lumber. It is a matter of diminishing returns, not much of it these days. As for the

code, the international code council is working on code for net zero, the code will get progressively more restrictive. The state of Idaho tends to water it down a little, at this point, prudent to not make it more restrictive than what the state decides. Proposed to leave our build better code alone, adopt the new building code. 7:06:23 PM Bundy, the biggest issue is not new homes, but bringing existing homes to new energy codes. 7:07:08 PM Simms believes we are grandfathered into our build better code.
