Hailey Small Business Grant Recipients Announced

34 Hailey Businesses Receive Funding

(Hailey, Idaho) Under the State of Idaho CARES Act, the Hailey Mayor and City Council created a city-wide grant program by which \$200,000 in grant funding was made available for Hailey businesses. In the first three weeks of December, city staff reviewed 44 grant applications amounting to \$374,000. Of these, 34 businesses were awarded funding to cover expenses they had incurred over the past six months. The grants range from \$423 to the maximum of \$10,000.

Details showing the type of businesses receiving grants, the amount approved, and the level of business hardship is below. Although economic hardship was not one of the grant requirements, we requested that information from each applicant. The City is waiting on State approval of these applications, and checks are expected to be issued to the businesses later this month.
